## Ministry of Power INVITATION FOR BIDS - LCC/21-22/ST/24/1 From Coal Suppliers Registered with LANKA COAL COMPANY (PVT) LTD SUPPLY OF COAL FOR LAKVIJAYA POWER PLANT

The Chairman, Special Standing Cabinet Appointed Procurement Committee (SSCAPC) of Ministry of Power on behalf of Lanka Coal Company (Pvt) Ltd (LCC) invites sealed bids to supply coal for the 900 MW Lakvijaya Power Plant, Sri Lanka, from coal suppliers registered with LCC, who are eligible to bid.

Lanka Coal Company (Pvt) Ltd was incorporated in January 2008 for the procurement of coal for coal fired power plants in the country. Shares of LCC are held by the Treasury, Ceylon Electricity Board, Sri Lanka Port Authority and Ceylon Shipping Corporation Ltd.
